



Important Requirements to enable attendance at our:

- PRE-SALE RAM INSPECTION DAY: TUESDAY 4TH AUGUST 2020
- PRE-SALE RAM INSPECTION DAY: WEDNESDAY 19TH AUGUST 2020
- ON PROPERTY RAM SALE DAY: THURSDAY 10TH SEPTEMBER

Taking into consideration the current COVID-19 circumstances and noting that livestock auctions have been declared exempt essential activities in the food production chain, we wish to note the following protocols, recommended by ALPA must be adhered to on sale day and during pre-sale inspections.

- **COVID-19 declaration MUST be completed by ALL attending**
 - You can find a copy of this declaration on our website - We will also have copies available for you to complete on sale day.
 - The Declaration includes: In the last 14 days have you -
 - ❖ *Been in a COVID-19 Hotspot?*
 - ❖ *Been Overseas?*
 - ❖ *Had contact with a Person who has confirmed case of COVID-19?*
 - ❖ *Do you have COVID-19?*
 - ❖ *Had COVID-19?*
- **Attendance:** With the safety of the community of utmost importance, the 2020 sale will not be the usual social day out. Please leave the family at home with only buyers to attend in person, or bid from the comfort of your own home online on AuctionsPlus or over the phone using your preferred Agent to assist. Essential staff including accredited Livestock Agents may attend but must also complete the declaration.
- **Interstate travellers: PLEASE REFER TO YOUR STATE TRAVEL PASS REQUIREMENTS.**
- **Practice Safe Social Distancing:** please ensure you are 1.5 metres apart at any one time.
- **Utilise Hand Washing Facilities:** We will have hand sanitiser available on sale day.
- **Pre-Inspection by appointment** is recommended. Please contact Ralph Diprose on 0488 436 332 or your preferred agent to organise an appointment.
- **Auctions Plus:** You are encouraged where possible to utilise Auctions Plus, phone bidding or to place an order with your preferred Livestock Agent.
 - ❖ **Reminder - If you are intending to operate on Auctions Plus and are not already registered, this registration must be completed 24hours prior to the sale.**

COVID-19 DECLARATION
